Bidding is open to all eligible bidders from all countries of the world not disqualified under the resolution of the competent organ of the Arab League or the regulations enforced in the Kingdom of Saudi Arabia.
- The Bagmati Irrigation Project, Department of Irrigation on behalf of the Ministry of Irrigation, Government of Nepal invites sealed bids from eligible and qualified bidders for following Contract Package as shown below.

- Bids must be valid up to 120 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of 2 to 5% of their bidding amount which shall be valid up to minimum 30 days beyond the bid validity period. Bid security issued by any Bank outside the Nepal must be counter guaranteed by Class A commercial Bank in Nepal.
- Pre-bid meeting will be held on 21st day from first date of notice publication at Office of Bagmati Irrigation Project, Karmaiya, Sarlahi, Nepal. The meeting will be preceded by proposed construction site visit. Attendance is strongly advised for all Bidders or their representatives but is not mandatory.
- In case of discrepancy or error in Tender notice, bid document and other document, Department of Irrigation reserves right to amend, correct at any time. Such amendment and correction shall be published in the National Daily Newspaper, the Notice Board of the Project office of Bagmati Irrigation Project, Karmaiya, Sarlahi, Nepal and Department of Irrigation, Jawalakhel, Lalitpur, Nepal and through on-line in E-procurement section of PPMO's website <https://www.bolpatra.gov.np>.
- The Item rates without VAT in Nepalese Currency shall be quoted in figures and words. If there exist any discrepancy between the rates in words and figures, the rates in words will govern.
- Department of Irrigation reserves the right to accept or reject wholly or partly any or all bids without assigning any reason whatsoever.
- Any bidder may submit the bid either by himself or as a partner in Joint venture (JV) provided that each JV partner has purchased bid documents by submitting a JV agreement along with the documents mentioned above for each of the partner firm.
